Notice to Exhibitors

The Trial Secretary is not responsible for emails not received. If you have not received a response to an email after 24 hours, please call the Trial Secretary by telephone.

The safety of the dogs is our primary concern. By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the veterinarian, judge, or Trial Committee.

Entry fees will not be refunded if the trials cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.

Entries must be made on Official AKC Entry Forms or copies and must include the signed Agreement and Rules. Junior Handlers must complete the back of the entry form. Please include only AKC titles on your entries.

No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance. Entries will not be accepted without fees or signatures.

Post Dated and Returned checks do not constitute a valid entry fee. There is a \$25 returned check fee.

Bitches in season will be permitted to run, but will be placed at the end of the running order in Tests and in catalog order for Trial classes.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.

Exhibitors are responsible for cleaning up after their dogs at show site and all hotel, motel, and campgrounds where they are staying while competing in these trials.

Exhibitors are responsible for being at the gate when it is their turn to run. The judge need not wait for any dog holding up a class. CWCCA has no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the arena when required.

All dogs must be on lead or crated at all times except when in the arena. See Chapter 1, Section 20 of the AKC Herding Regulations.

Dogs must wear a simple well-fitting buckle, snap lock, or slip collar (no tags) or may work without a collar at Trial levels.

Owners are responsible for errors in making out entry forms, whoever may have made such errors. No entry will be refunded in the event of such errors or cancellation of entries after the published closing date. Errors in entries made by the exhibitor cannot be corrected after the closing date other than move ups. No refunds for duplicate entries.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

Cardigan Welsh Corgi Club of America, their Board, Members, and RottiEwe Farm and its employees will not be liable for any loss or injury which may be sustained through disappearance, loss, theft, communicable disease, parasites, injury and/or death of dogs entered in this event.

CWCCA does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.

CWCCA Covid Procedures for Exhibitors and Spectators

Following much discussion & consideration of MO/ CDC guidelines, we believe it is possible to have a safe & fun trial as long as we follow a few simple protocols.

Distancing:

- Maintain 6 feet or more from others while at RottiEwe Farm.
- Park spaced such that safe distance can be maintained around vehicles if possible and follow any directions from parking attendant. We do not have the ability to pull stuck vehicles out!
- Maintain appropriate space & yield way at gates & entrances.

Face Coverings:

- Everyone must wear a face covering while at RottiEwe Farm.
- Face coverings may be pulled down while competing in the arenas. Please restore as you leave the arena. There will be a limited number of disposable masks also available.

Off-limit Areas:

- Inside Pavilion building where secretary will be working.
- Barns and personal areas of RottiEwe Farm.

Maintaining Good Hygiene:

- We suggest judicious personal use of hand sanitizer as you contact latches & handles. We will have hand sanitizer stations available near the porta-potty, auction table, & ribbon / prize table.
- Surface sanitizer will also be available outside the porta-potty. We ask that you spray all surfaces you touched after using.
